2. Relationships

3. Self Esteem

We believe that self-esteem and respect are central to the development of the student and promotes learning.

4. Personal Safety

The Welfare Board in the Student Common Room will display relevant information on personal safety issues and students will be informed at the Welcome Meeting. Students and staff will be aware of the identity of the Welfare Officer who is responsible for helping students when problems arise. All staff will be aware of the identity of the First Aiders in the College and what the procedures are for dealing with students who need first aid. Students will be able to speak to their class teacher if they need help or are concerned and the teacher will alert the appropriate member of staff.

Implementation

The Principal of the College has overall responsibility for the implementation of the monitoring of the safety of each student studying in the College. The Principal will ensure that the Pastoral Care Policy is monitored and implemented. He/she will work with staff to ensure they are kept up to date and trained. He/she will make sure that non-teaching staff are familiar with the Pastoral Care Policy and give assistance when required.
